Sub:- Measures for Prevention of spread of Corona Virus under Epidemic Disease Act, 1897.

Ref:- Govt Notification S.O. 104, dated: 16.03.2020.

ORDER


Whereas, to prevent the spread of the Corona Virus, the Government of UT of J&K, invoking Section 2 of Epidemic Disease Act 1897, has issued, vide Notification No. S.O.104 of 2020, dated:16.03.2020, J&K Epidemic Disease (COVID-19) Regulation, 2020 and has notified Corona Virus (COVID-19) as an Epidemic disease (copy enclosed);

Whereas, under the said notification the Government has empowered District Magistrates to take certain actions for prevention of the spread of the Corona Virus, which has posed a serious threat to the life of the public at large scale.

Therefore, I, Shahbaz Ahmed Mirza, KAS, District Magistrate, Bandipora hereby issue following orders/ instructions, to be effective within the limits of District Bandipora, with immediate effect:-

1. All the Medical/ Para-Medical officials including CMO, MS's, BMO's, CHO's and the officers/ officials deployed in District/ Block Control Rooms, RRTs and in Community Surveillance Teams are designated as "Surveillance Personnel", in terms of Section-2 (b) of the Regulations, enabling them to discharge their duties under section 3 & 5 of the Regulations to detect/ examine and quarantine any Corona infected person.
2. All the ADM's, SDM's and Executive Magistrates 1st Class working in the District are hereby authorized to take steps under Section 5 for enforcement of Provisions of the Regulations.
3. Concerned SHOs/ DOs of Police Station/ Police Posts shall provide all necessary assistance to the Surveillance Personnel and the Magistrates in discharge of their duties to implement the Provisions of these Regulations.

4. All Medical Officers/ Practitioners both in Government Institutions/ Registered Private Institutions shall ensure to notify the District Control Room, (alongwith duly filled self declaration forms) of the Person(s) having travel history to COVID-19 affected Countries and having complaints of High Fever or Cough or Respiratory difficulty or even without any symptoms of Corona Virus (Epidemic Disease).
5. Persons having the travel history to any COVID-19 affected Country with or without any sign/ symptoms of COVID-19 or any other person having contact with such a person and any other person having the signs/ symptoms of CORONA VIRUS shall inform the nearest control room or the concerned Surveillance Team forthwith. Concealment of such information shall be treated as violation of the Provisions of the Regulations and this order.
6. Violation of the provisions of these Regulations and this order shall invite prosecution under section 188 of the Indian Penal Code, 1860, in terms of Section-6 of the Regulations.
