



Subject: Restrictions under Section 144 CrPC.

### ORDER

Whereas, Novel Corona Virus Disease 2019 (NCOVID-19) has been declared as Global Pandemic by World Health Organization in view of its outbreak at global level affecting many countries including India.

Whereas, in view of the advisories of Health authorities regarding containment/prevention of NCOVID-19, this office has issued orders vide No:DCB/PS/2019-20/1730-36 dated 07-03-2020 for banning of large social/official gathering in the District and a number of steps/ directions issued vide order No:DCB/PS/2020/1877-1996, dated:17.03.2020 under Epidemic Disease Act, 1897 and vide order No:10/DCB/PS/2019-20, dated:17.03.2020 under Disaster Management Act, 2005.

Whereas, first positive case of Corona Virus has been reported in District Srinagar and thus more stringent measures are required to control the spread of the virus in the District.

Now, therefore, in view of the above mentioned facts, & in the interest of safety & well being of general public at large, I, Shahbaz Ahmed Mirza, KAS, District Magistrate, Bandipora, in exercise of the powers vested in me under section 144-CrPC do hereby impose following restrictions within the territorial limits of District Bandipora, with immediate effect:-

1. No public movement, assembly, gathering or procession involving 05 or more than 05 persons shall be allowed in the District including Towns and Villages.
2. No Public Transport shall ply in the district till 31<sup>st</sup> March, 2020. However, plying of Sumos/ Autos shall be reviewed after three days.
3. All Restaurants, Open Food Courts, Roadside eateries, Gyms, Beauty Parlours, Snooker Clubs, Parks etc, shall remain closed.
4. There shall be Medical Screening cum Security check-posts at Sara-Dangarpora/ Sumbal Bridge/ Ajas/ Watlab Top jointly manned by Personnel of Police, Health and Revenue Departments.
5. However, these restrictions shall not apply to the Government vehicles/ ambulances and Government staff involved in efforts against COVID-19 & other staff of other emergency services.

Any violation of this order by any person shall invite action under Indian Penal Code. This order shall be given wide publicity by way of announcement on loudspeakers and by affixation of copies thereof at conspicuous places.
