
Sub: - Ban on movement of individuals for all non-essential activities between 10:00 PM to 5:00 AM.

ORDER

Whereas, the Union Home Secretary in the capacity as Chairperson, National Executive Committee(NEC) vide order No:- 40-3/2020-DM-I(A) Dated 27.10.2020 has issued guidelines for implementation of the extended lockdown in containment Zones (Red Zones) till 30.11.2020, the continuation of unlock guidelines outside containment Zones(Red Zones)and Pursuant to the instructions of the Government conveyed vide Government Order NO:-86-JK (JKDMRRR) of 2020, dated:30-10-2020 & as a precautionary measure in view of COVID-19, I, Dr. Owais Ahmad, IAS, District Magistrate, Bandipora, in exercise of powers vested in me under Section-144 CR.PC and Sec 34 of Disaster Management Act 2005, do hereby impose complete ban on movement of individuals for all non-essential activities between 10:00 PM to 5:00 AM in the entire District Bandipora upto, with immediate effect, till 30th Of November 2020.

Sr. Superintendent of Police, Bandipora, shall implement the orders. Any violation of this order by any person shall invite action under IPC.
