ORDER:

Whereas, Govt. of Haryana issued Notification No. 32/3-IOSP-020/3318-24 dated 27-05-2020 vide which following guideline are issued in the public interest :-

1. The Central Government and the State Government have made it very clear that in the interest of Public Safety during the prevailing of pandemic, wearing of a Face Cover whether a mask, an improvised a mask, a home-made mask or a face cover using clothes shall be mandatory for every person while being in public places and a workplace also.
2. Also there needs to be strict prohibition of spitting in public places.
3. Now, therefore, it is ordered that every violation of the above these prohibitions will be punished by imposing fine of Rs. 500/- Non-payment of fine by the violator, he will be liable for punishment under section 188 of the Indian Penal Code.

The notification empowers undersigned to designate officers for implementation of these guidelines. Accordingly, every officer designated below shall be responsible for implementation of these directions:-

- a. All Tehsildar's/Naib Tehsildar's.
- b. All BD&PO's/SEPO's.
- c. Secretary /ME/BI of Municipal/Mkt. Committees.
- d. Police Office above the rank of ASI.
- e. Medical Officer as designated by concerned Civil Surgeon or concerned Hospital/CHC/PHC premises.
- f. Officer above the level of Supervisor in Women and Child Dev. Department, Nuh.
- g. Officer above the level of Head Master in Education Department, Nuh.
- h. Officer above the level of the Inspector in Food & Supply Department, Nuh.
- i. Officer above the level of the ADO in Agriculture Department, Nuh.
- j. Officer above the level of the J.E. in All Technical Department, Nuh.
- k. Officer of the Veterinary Surgeon and above the level in Animal Husbandry Department, Nuh.




- I. All Head of Offices in the District, Nuh.
- m. All Incident Commander/Duty Magistrate of n-COVID-19 in the District Nuh.
- n. All Bank Branch Managers and Postmaster of Post offices in the District Nuh.

All the above designated officers are directed to collect Challan Book (dully attested by City Magistrate, Nuh) from the District Nazar Branch (Room No. 325) 2nd Floor, Mini Secretariat, Nuh) office of the Deputy Commissioner, Nuh and ensure that all the challans are done through this Challan Book only. All the above designated Officers shall also ensure that Challan amount shall be deposited in to the receipt head of the Govt. i.e. 0210-01-800-92-other items.


Civi Surgeon, Nuh at Mandikhera is hereby directed that Challan amount shall be deposited into the receipt head of the Govt. i.e. 0210-01-800-92-other items to ensure that weekly settlement report shall be submitted to the District Nazar Branch of this office.
