ORDER

Whereas, directions have been issued by the National Disaster Management Authority (NDMA) under Section 6 (2) (i) of the Disaster Management Act, 2005 and further to implement these directions, guidelines have been issued by the Union Home Secretary, Government of India vide No. 40-3/2020-DM-I(A) dated 30.09.2020 to the State/UT Governments for strict implementation as provided in the annexure there to.

And whereas, the Chief Secretary-cum-Chairperson, Haryana State Executive Committee, vide order bearing no. DMC-SPO-2020/11573 dated 01.10.2020 has also directed that the aforementioned guidelines issued by NEC to re-open more activities in areas outside the Containment Zone and to extend the lockdown in Containment Zones on upto 31.10.2020 in State of Haryana.

The aforementioned guidelines issued by the Ministry of Home Affairs, Govt. of India and Govt. of Haryana are to be implemented by the District Disaster Management Authority in letter and spirit in district Nuh. Hence, in exercise of the powers conferred under Section 30 of the Disaster Management Act, 2005, the Superintendent of Police, Nuh and all the SDMs-cum-Incident Commanders are hereby ordered to ensure strict compliance of the guidelines as referred/provided in the Annexure to Ministry of Home Affairs Order No. 40-3/2020-DM-I (A) dated 30-09-2020.
