

Order

District Administration, Nuh.

Whereas, directions have been issued by the National Disaster Management Authority (CDMA) under Section 6(2)(i) of the Disaster Management Act, 2005 and to implement these directions, guidelines have been issued by the Union Home Secretary, Government of India vide No. 40-3/2020-DM-1(A) dated 29.04.2021 to the State/UT Governments for strict implementation.

And whereas, the Chief Secretary-cum-Chairperson, Haryana State Executive Committee, vide order bearing no. DMC-SPO-2020/5215 dated 02.05.2021 hereby declares lockdown from 03.05.2021 (05.00 am onwards) to 10.05.2021 till 05.00 am in the state of Haryana alongwith directions to all the departments of the state Govt. and District Administration for strict implementation of enclosed guidelines during the period of lockdown in letter and spirit.

Whereas, all residents of the district shall stay indoor during the above mentioned lockdown period. No person shall leave their homes or shall move on foot or by vehicle or travel or stand or roam around on any road or public places during the period of lockdown.

All concerned are hereby ordered to ensure strict compliance of the guidelines as referred/provided in the Annexure, the extracts relevant guidelines of which are reproduced here below for ready reference and compliance.

The aforementioned guidelines issued by the Ministry of Home Affairs, Govt. of India and Govt. of Haryana are to be implemented by the District Disaster Management Authority in letter and spirit in district Nuh.


Therefore, in exercise of the powers conferred under Section 30 of the Disaster Management Act, 2005, the Superintendent of Police, Nuh and all the Incident Commanders-cum-Duty Magistrates and all concerned are hereby ordered to ensure strict compliance of the guidelines as referred/provided in the Annexure.

The District Administration Nuh order bearing No. 323-337/Camp dated 30.04.2021 regarding Covid guidelines enforcement committee in Nuh district shall ensure its strict implementation.

Failure to obey these orders shall be punishable under section 188 of I.P.C with punishment of serves fine and imprisonment & other relevant section of the act.

In view of requirement of the situation which has become emergent, this order, is being passed ex-parte. It shall be published for the information of public through the press and publicity van of public relations department and by affixing copy at notice board of District Courts, Zila Parishad, Sub Divisions, Tehsils, MCs, Panchayat Samities, Police Stations.


