

ORDER

In compliance of letter memo no. A-120024/34/Advisory CAQM_NCR/2021-CAQM/983-985 dated 23/09/2021 of "commissioner for Air Quality Management in National Capital Region and Adjoining Area, New Delhi" received vide letter memo no HSPCB-040001/26/2020 dated 27/09/2021 received from Haryana State Pollution Control Board, Panchkula (Copy attached) regarding **"Prohibition/restriction/total ban on the sale and use of all kind of fire crackers during the COVID-19 pandemic in the NCR and all cities/towns in the country where the ambient air quality fails under the 'poor' and above category."**

Whereas, Air Pollution poses serious environment risk with adverse effect on the health of people particularly vulnerable sections of the populations like children, elderly and people with pre-existing respiratory illness/heart diseases etc.

In this regards, commission for Air Quality Management, New Delhi has passed the following orders/direction.

Para no. 13 the state Government of Uttar Pradesh, Haryana, and Rajasthan are required to take all measures to control and abate Air Pollution especially during winter months and regulate the sale, use and bursting of firecrackers in respective NCR district including the following:

- i) Strictly comply with various Orders/Directions of NGT and Hon'ble Supreme Court, on the ban/prohibition on the sale and use of all kind of firecrackers in NCR.**
- ii) Ensure total ban on sale and use of all kinds of firecrackers, during the COVID-19 pandemic, where the ambient air quality falls under "poor" or more then poor category.**

The AQI of District Nuh mostly remained in moderate/poor category during October -2020 and almost 15 days during November-2020. The AQI in the district presently also running in moderate category since 01/10/2021 it is also evident to mention that the AQI from 17/10/2021 to 20/10/2021 remain in the category of satisfactory and good because of rainfall. The AQI again rose in the category of moderate on dated 21/10/2021 and expected to be in this category only or it may be deteriorated to moderate to poor in the coming days due to impact of climate/weather conditions.

Therefore in compliance of above mentioned letter and various orders/directions of NGT and Hon'ble Supreme Court and in exercise of the power vested in me as Chairperson of District Disaster Management Authority, District Nuh and other powers vested in me under the explosive rules, 2008. I, Shakti Singh, IAS, District Magistrate Nuh do hereby order to prohibit the sale and use of all kinds of firecrackers in District Nuh.

In this regards following teams are hereby constituted to ensure total ban on sale and use of all kind of fire crackers during the COVID-19 pandemic in the District Nuh due to poor category of Air Quality.

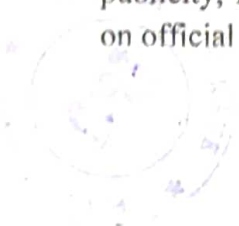
The District Higher Education Officer, District Nuh, District Education Officer and District Elementary Education Officer are hereby directed to aware collage and school students about the harmful effects of firecrackers through seminars, Workshop, Group discussions etc.

The Secretary of Red Cross, District Nuh, District Municipal Commissioner, Nuh, all SDMs, Duty Magistrate, SHOs of District Nuh, EO Nuh, Municipal Committees, Tauru, Ferozepur Jhirka, Punhana & Nuh shall ensure strict implementation of this order.

This order shall come into force with immediate effect till further orders.

Any person contravening this order shall be punishable under section 51 to 60 of Disaster Management Act 2005 and other relevant provisions of different laws and regulations.

The District Public Relation Officer, District Nuh is directed to aware the Public about the ill and harmful effect of fireworks and cautioning people about the health Hazardous of bursting fireworks through Nukkad Nataks, print and electronic media, further he is directed to give wide publicity to this order throughout the District Nuh and this order should be sent to the press for wide publicity, District informatics officers, District Nuh is directed to host the order on official website of District Nuh.
