ORDER UNDER SECTION 144 Cr.P.C.

Chief Electoral Officer, Punjab informed vide letter No. Elec-2019/R-2133 Dated: 10/03/2019 that Lok Sabha Elections-2019 will be held in Punjab on 19/05/2019 and the Model Code of Conduct has come into force from 10/03/2019. During Elections it has been made to appear that commercial establishments/shopkeepers engaged in the business of Restaurants/Dhabas, Party venues Liquor Vends, Vendors etc. sitting by the road side and on the public places are operating till late in the night causing annoyance. They are disturbing the public peace and tranquility leading to lawlessness and disorderly behaviour.

And whereas, I, Gurpreet Kaur Sapra, IAS, District Magistrate, Sahibzada Ajit Singh Nagar am of the opinion that such commercial operations should not be carried on till late in the night, and therefore order that running of commercial establishments/shops etc. in trades/services such as running of Restaurants/Dhabas, Party venues, Clubs; Liquor Vends and hawkers by the road sides and on the public places between midnight (12:00 AM) and 06.00 AM in the jurisdiction of the District, is prohibited. Sale & service of liquor will however be governed by the Excise Law.

The owner of the business shall be responsible for his/her premises for abiding by the NDPS Act, instruction/laws which are applicable to his business. The Private security so deployed by the owner shall be made aware to not allow anybody to take inside the premises any **such substance** which is in violation of the NDPS Act 1985. If any person enters such premises and the fact come to the knowledge of the owner/private security or the manager of the premises the information shall be immediately shared with the local police.

Provided that the order relating timings shall not apply to hospitals, authorised chemist shops and Petrol pumps.

No establishments shall run their business without a valid license.

This order shall come into force with effect from 13/03/2019 to 10/05/2019.

In view of the emergent nature of the order, it is being issued ex-parte and is addressed to the public in general. The compliance of these orders shall be done by the local police officers/officials.

This order shall be promulgated by the announcement through publicity vans and by affixing copies thereof at the Notice Boards of the Government offices of this District and publication in the newspapers having circulation in the area.
