TO WHOMSOEVER IT MAY CONCERN

WHEREAS, keeping in view the recent rise in COVID-19 cases, industrial oxygen supply has already been banned in the country. In order to facilitate supply of medical oxygen to hospitals, empty cylinders are required to supplement availability with the hospitals treating COVID19 patients;

WHEREAS, the District Disaster Management Authority is empowered under Section 34(j) to procure exclusive or preferential use of amenities from any authority or person;

Therefore, I, Girish Dayalan, IAS, District Magistrate in exercise of powers conferred under National Disaster Management Act, 2005, order that all industrial or other units in possession of oxygen cylinders shall make them available to the Oxygen Management Committee headed by Sh. Pavitar Singh, PCS, EO GMADA immediately. The Nodal Officer for procurement of cylinders shall be Sh. Sukhdeep Singh, District Programme Officer (Ph. 9914400406). The owners and management of the units shall be held personally responsible for any lapse in this regard.


