Order

WHEREAS, there has been a steep rise in number of cases and mortality in the district and to avoid a situation of further spread in the community, it is necessary to take emergent measures.

WHEREAS, the Additional Chief Secretary, Home Affair and Justice, Govt. of Punjab issued instructions dated 02.05.2021 regarding entry of persons in the State. Therefore the following is ordered: -

- i. Those entering the State via District shall only be allowed with either of : -
 - a. Negative Covid report not more than 72 hours old, or
 - b. Vaccination certificate (at least one dose) over 2 weeks old.
