ORDER

1. WHEREAS, COVID19 has already been declared as a pandemic by the World Health Organization (WHO) and National Disaster Management Authority.
2. WHEREAS, as the entry of inbound persons into the State needs to be regulated in line with the protocol of the Home Department of the State of Punjab for the containment and prevention of the spread of COVID19.
3. THEREFORE, I, as Chairperson DDMA, am satisfied that in view of the emergent nature and potential magnitude of the pandemic and as per the instructions received from the Government of Punjab; for the purpose of preventing the spread of the disease and enable effective surveillance, tracing and tracking the movement of passengers it is hereby directed that the following shall be ensured for air passengers at CHIAL/ Mohali:
 - 1) All passengers shall either produce Negative Covid report not older than 72 Hours or a vaccination certificate (atleast one dose) over two weeks old before boarding the flight. The airline shall be responsible for ensuring the same.
 - 2) All incoming passengers *belonging to Punjab/ whose destination is Punjab* shall install COVA App on their smart phones, before exiting the Airport. They shall also necessarily turn on Bluetooth and GPS.
 - 3) The Airlines shall publicize this extensively to ensure that this information is made available to all the passengers boarding the flights well before their departure.
 - 4) The Station Managers of the respective Airlines shall be responsible to implement the above orders. Any violation shall invite penal action as per law.
 - 5) CEO, CHIAL shall monitor this and ensure compliance of these directions and report deviations, if any.
 - 6) The Nodal Officer Sh. Mahesh Bansal, EO (H) Gmada SAS Nagar (98159-79797), shall ensure strict implementation in co-ordination with CEO, CHIAL.
5. All the concerned authorities shall ensure the strict compliance of these instructions.
