**Sub: - Notification under section 9 & 9-A of Land Acquisition Act 1990 Svt as amended upto date, for acquisition of Land for the land coming under the relocation of Petroleum depots from Channi Himmat, near Railways Station to villages Pargalta and Kahna Chargal, Tehsil & District Jammu for land measuring 555 kls and 09 mls (541 kls and 05 mls in village Pargalta and 14 kls and 04 mls in village Kahna Chargal).**

Whereas, the land specification whereof are given below in this notification is required for public purpose viz. for relocation of Petroleum Depots from Channi Himmat, near Railways Station to villages Pargalta and Kahna Chargal, Tehsil and District Jammu for which notification u/s 4(1) was issued by this Collectorate vide notification no. LA/ACR/Oil-Depots/Pargalta-Chargal/2016-17/1123-31 dated 15-11-2016.

Whereas, the disposal of objections u/s 5(A) were heard by the then Collector Land Acquisition, Jammu and the case after due care submitted to the Government through proper channel for issuance of notification u/s 6, 7 & 17 of Land Acquisition Act, 1990 Svt.

Whereas, after considering all the aspects of the acquisition and urgency in the case to relocate Oil Depots at Pargalta and Kahna Chargal, the Government notified the above said land u/s 6,7 & 17 vide notification no. 416-Rev (LAJ) of 2018 dated 12-11-2018


