



Desirable	The applicant should have knowledge of customs, manner and dialects of Himachal Pradesh and suitability for appointment in the peculiar conditions prevailing in the state.
Age limit	Between 18 to 45 years (as on 01-01-2018). The upper age limit is relaxable for SC/ST & other categories of persons to the extent permissible under the H.P. Government.
Mode of Selection	(i) Driving Skill Test. = Qualifying Nature (ii) Written Objective type Screening test = 85Marks of only those who qualify the Driving Skill Test. Syllabus	Written objective type screening Test (MCQ) consisting of General English and Hindi of Matric standard, General Knowledge of Himachal Pradesh, Motor Vehicle Act & Rules, First Aid and Mechanical Assistance etc.

Mode of payment:-	The fee will be accepted only in the shape of Demand draft/Bank Draft issued in favour of Deputy Commissioner, Una District Una (H.P.)
