

NOTIFICATION

Whereas, on the recommendation of SP Una, a meeting was held on 04-05-2018 to deliberate upon the measures to regulate the traffic movement and ease the traffic congestion on the main roads passing through Una, Mehatpur and Santoshgarh; and wherein it was unanimously resolved to take effective steps immediately in the interest of the safety and convenience of the road users; and whereas a draft Notification No. 6827-40/MA-MC-1 was issued by this office on 06-06-2018 calling upon general public to file their objections, if any, within 30 days; and whereas the said period of 30 days has elapsed and no objection in this regard was received from the public ;

Therefore, I, Rakesh Kumar Prajapati, District Magistrate, Una in exercise of powers vested in me under section 115 & 117 of the Motor Vehicles Act, 1988 and in pursuance of powers delegated to me by the Govt. of Himachal Pradesh, Transport Department Notification No. TPT-E (2) 12-2001 dated 02-06-2003, and all other powers enabling me in this behalf, do hereby notify the following:-

- 1) "No Parking Zone" inside the yellow line on National Highway/ State Highway on following stretches of roads:-
 - i) National Highway 503 "Om Bhujia Bhandar to Lal Singhi Bridge Una"
 - ii) State Highway 32 "Red Light Chowk Una to Railway Station (Hamirpur Road) Una."
 - iii) National Highway 503 "Mehatpur Toll Barrier to Nayair Petrol Pump Mehatpur"
- 2) Santoshgarh Main Bazar will be closed for all heavy vehicular traffic from 10:30 AM to 07:00 PM.
- 3) One way traffic system will be allowed for light vehicles from Santoshgarh Main Bazar (Near Ravi Das Temple) for entering the vehicles and Near Silver Oak Palace for outgoing of vehicular traffic.
- 4) Ambulance, Fire Tender & other emergency vehicles are exempted.
- 5) Superintendent of Police, Una shall ensure compliance of these orders.

These orders will come in force from the date of their publication in the Govt. Gazette.
