एतदद्वारा निविदा दस्तावेजों में स्थापित नियम एवं शर्तों अनुरूप योग्य ठेकेदारों/फर्मों/पंजीकृत टेक्सी यूनियनों/टूर ट्रवेल एजेंसी से विभिन्न विभागों/कार्यालयों द्वारा प्रयुक्त किये जाने वाले वाहनों को किराये पर लेने के लिए उपायुक्त ऊना के कार्यालय द्वारा निर्धारित प्रपत्र पर आवेदन आमंत्रित है, जोकि दिनांक 15-07-2020 को पूर्वाह्न 11:00 वजे (प्रातः) इस कार्यालय में पहुँच जाने चाहिए व उसी दिन अपराह्न 3:00 वजे आवेदनकर्ता या उनके प्राधिकृत प्रतिनिधि की उपस्थिति में खोले जाएंगे ! निविदा दस्तावेज 13-07-2020 तक किसी भी कार्य दिवस को मुबलिक 1000/-रूपये (अप्रतिदेय)के नकद भुगतान करने पर उपायुक्त कार्यालय के (कमरा न. 214) से प्राप्त किये जा सकते हैं! विस्तृत नियम एवं शर्तों को इस कार्यालय की वेबसाइट www.hpuna.nic.in पर देखें !

NOTICE INVITING TENDER REGARDING OUTSOURCED VEHICLE


Sealed tenders are invited on the prescribed proforma from all the registered taxi union/firms/tour and travelling agencies to provide taxis services to the Government /Semi government offices/corporations/Boards and institutions situated in Una District(Himachal Pradesh)for the period of one year(01-07-2020 to 30-06-2021). All interested party may submit their sealed tendered along with earnest money (tender security) to the tune of Rs. 100000/-(one lac) only through bank draft in the name of the Deputy Commissioner, Una, with the District Nazar on or before 21-07-2020 up to 11:00AM and will be opened at 3:00 PM on the same day in presence of tenderer or their authorized representatives, who so may wish to be present there. The tender form can be taken on any working day on a cash payment of Rs. 1000/-(non refundable) only from District Nazar. The detailed terms and conditions of the tender are as under:-

1. The hire charges shall be applicable from 01-07-2020 and shall be valid for one year from the date of opening of the tender. *
2. The Vehicle shall be in good working order and the model should not be older than 3 year(s) and total mileage covered should not exceed 60000 Kms .
3. Monthly running of the vehicle would be 1500 Kms. approximately. This is only indicative and the vehicle would be required to run more or less than this figure as per requirement without any limit. *
4. The registration fee, payment of route permits renewal of route permits, payment of all taxes, levy of toll tax, entry tax at barriers and timely passing of vehicle, will be the sole responsibility of the contractor. It will be the responsibility of the contractor to obtain the necessary permit to ply the vehicle on restricted / sealed roads in city of Shimla.
5. The contractor shall deploy driver having valid driving license with at least 5 years experience of driving on all types of roads.
6. In no case the driver or vehicle will be allowed to replace without prior approval of the Department. *

7. Driver deployed on the vehicle should have a mobile phone with a local number for coordination. The expenditure on this account shall be borne by the contractor. *
8. The contractor shall engage Driver who is medically fit.
9. The contractor shall ensure that the antecedents of the driver are verified by the Police to the satisfaction of the department.
10. The journeys performed by the driver / owner on account of filling of fuel, repairs, services, and halt at outstation / headquarter; journey from place of residence to place of duty/ place of parking shall not be paid by Department. *
11. Successful bidder will deposit a security amount of Rs. 100000/- in shape of FDR duly pledged in favour of Deputy Commissioner Una; security amount shall stand forfeited in case of violation any of the Terms and Conditions of tender/contract agreement.
12. Vehicle should be made available 24 hours on all the days within half an hour call. *
13. The vehicle shall be plied on all kind of roads, within and outside Himachal Pradesh including rough and tough roads.
14. All petty/ major repairs of the vehicle shall be carried out by the contractor at his own cost.
15. The Driver / Contractor shall keep and maintain a log book with the vehicle, which should be regularly updated. The staff of department using the vehicle will verify the journey in the log book. In case of incomplete log book, it shall be considered that vehicle has not been used by the Department. *
16. In case of any breakdown the contractor will provide substitute immediately, otherwise a penalty of Rs. 2500/- per day will be imposed and the recovery to this effect will be made from the monthly running bill. In case the contractor fails to provide the vehicle within the scheduled time due to reason beyond his control or due to the force majeure no penalty shall be imposed. However, the payment for these days shall not be made by the Department.*
17. The contractor of the vehicle shall be responsible for compensation payable arising out of accident / payment to third party , if warranty . No compensation in case of accident / damage to vehicle or for death/ injury to the Driver will be made by the department.
18. The losses caused to vehicle due to the negligence on the part of the driver of the vehicle will be borne by the contractor.
19. The Contractor shall place a Plate at a suitable place on the taxi indicating that the Taxi has been hired for Government Duty.

20. The base rate for consideration of L-1 status of any firm shall be considered on the basis of rates quoted in respect of fixed per month rates and full day rates for 150KMs journey or 8 hour duty.
21. The committee will have the right to negotiate the rates with the firms on any field.
22. Night halt charges for local or out station journey shall be paid only if the vehicle is retained beyond 10:00 PM in this case charges for extra time beyond 8 hours shall not be applicable.
23. Service tax shall be payable extra as applicable ob above rates against submission of documentary evidence.
24. The tendering process or tender of any firm can be rejected by the committee at any time without any prior notice to the tenderer.

NOTE * The condition marked with * may be relevant in case vehicle/taxi is hired on a regular/attached basis for a fixed period. These conditions may not be relevant in case taxi is hired for a few days/few hours on non-regular basis.
