Order

Whereas it has come to the notice of undersigned that there are stocks of unutilized oxygen cylinders lying with various traders, dealers, industrial units, private hospitals and persons in the district;

Whereas there is an impending shortage of oxygen cylinders in the district for use in DCHC Haroli and DCHC Palkwah and oxygen cylinders are urgently required to save the lives of the COVID-19 patients;

Therefore, I, Raghav Sharma, IAS, District Magistrate, Una, in exercise of the powers vested in me under Sections 33 and 34 of Disaster Management Act, 2005 do hereby order in large public interest that:

1. All traders, dealers, industrial units and private hospitals and private persons shall forthwith declare their complete stock of oxygen cylinders to the District Magistrate, Una within a period of 24 hours from this order. Any stock which remains undeclared and is discovered thereafter shall be liable to confiscation thereafter.
2. All Sub Divisional Magistrate shall immediately constitute teams of Executive Magistrate, Civil Supplies Inspectors, EO Industries and Police officials to physically inspect all godowns, industrial units and private hospitals in their jurisdiction and prepare an inventory of oxygen cylinders stored in their jurisdiction. Additional Deputy Commissioner, Una shall maintain the complete inventory of oxygen cylinders at the District level.
3. All unutilised oxygen cylinders in possession of any person shall be placed by the SDM at the disposal of the health department as and when required by them on such terms and conditions as he/ she deems fit.
4. In case of severe emergency and shortage for COVID-19 patients the Sub Divisional Magistrate shall be competent to immediately take into possession all the stock of oxygen cylinder available with any person irrespective of their utilization status.
