ORDER

In continuation of orders no. 667-691/DRO/Relief dated 06.05.2021, 723-751/DRO/Relief dated 09.05.2021, 834-861/DRO/Relief dated 15.05.2021, 951-986/DRO/Relief dated 19.05.2021 and 1044-1056/DRO/Relief dated 21.05.2021 and after considering the current situation of COVID-19 pandemic and fatalities in the District, I, Raghav Sharma, IAS, District Magistrate-cum-Chairperson, DDMA, Una, in exercise of the powers conferred upon me under Sections 33 and 34 of the Disaster Management Act, 2005 and in welfare of the public at large, do hereby order and direct that the "Corona Curfew" with exemptions and restrictions issued vide above orders shall stand further **extended till 6 AM of 31st May 2021**.

Any person violating these curfew measures will be liable to be proceeded against as per the provisions of Section 51 to 60 of the Disaster Management Act-2005, Section 188 of the IPC, Section 111 read with Section 114 & 115 of HP Police Act-2007 and other legal provisions as applicable.

This order shall come in force with effect from 6 AM on 26.05.2021. Issued under my hand and seal on 25.05.2021.


