ORDER

In view of the current situation of COVID-19 pandemic and in pursuance of order no. Rev (DMC)(C)20-2/2020-COVID-19 Government Of Himachai Pradesh, Revenue Department-Disaster Management Cell dated 05-01-2022, I, Raghav Sharma, IAS, District Magistrate-cum-Chairperson, DDMA, Una in exercise of the powers conferred upon me under Sections 33 and 34 of the Disaster Management Act, 2005 and in welfare of the public at large, do hereby order that:

- 1. "No Mask-No Service" policy will remain operational in the District.
- 2. There shall be Night Curfew in the District from 10 PM to 5 AM.
- 3. In all indoor/covered areas and open spaces including marriage palaces & banquet halls, for all social/ academic/ sports/ entertainment/ cultural/ political/ religious and other congregations, 50% of the capacity shall be allowed subject to adherence of the COVID-19 safety protocols and COVID appropriate behaviour.
- 4. Hotels & Restaurants shall remain open subject to strict adherence to COVID Appropriate Behaviour.
- 5. Cinema Halls/ Multiplex/ Sports Complex/ Stadiums/ Swimming Pools/ Gymnasiums shall remain closed till further order.
- 6. No langar shall be allowed in religious places/ places of worship.

All the SDMs, Executive Magistrates, Police and local authorities of District Una are directed to ensure strict compliance of the above directions. Violation of the above orders will be a punishable offence under the Disaster Management Act, 2005 and all the SDMs, Executive Magistrates, DSPs and SHOs of the District Una and officers authorized by the Sub Divisional Magistrate will be authorized to initiate legal proceedings under Section 60 of Disaster Management Act, 2005.

Penal Provisions

Any person violating these measures and not following COVID appropriate behavior will be liable to be proceeded against as per the provision of Section 51-60 of the Disaster Management Act, 2005, besides entailing legal action under Section 188 of the IPC, and other legal provisions as applicable.

This order will come into effect immediately and shall remain in force till further orders.
