CIRCULAR.

In pursuance to Govt. Order No.CS/COVID-19/01/2020/021/ Dtd 16th April 2020, an Office notification was issued vide No. TJ-263/2020/ Dtd 18/4/2020 to adhere to the direction of Ministry of Home affairs , Gol, New Delhi vide No. 40-3/2020-DM-I(A) Dtd. 15/04/2020 and 01/05/2020, i.e mandatory wearing of mask/ face covers while coming out of house for any purpose and in offices and public places. However, it is reported that many persons are not using masks in offices and public places. The Executive Magistrates have been already directed to impose fine as fixed by the Govt. i.e. Rs.100/- for each violation.

Therefore, the Executive Magistrates are directed once again to strictly implement the order of MHA and the State Govt. in respect of wearing Mask/ Handkerchief/ Scarf in offices as well as in public places.

Further as per the order No. AP/HFW-12/2020/453/ Dtd. 17/04/2020 of Chief Secretary, GoAP the officer viz, BDOs/Police (Inspector & above) DLRSO/DIPRO/ Asstt. Director (DACO,DOKAA/ Dy. Director Agriculture, Textile & Handicraft, ICDS, Industries) /DHO/ DDMO/ DFDO/ DLIO/ DVO/ DFCSO/ Executive Engineer (PWD,RWD,WRD,PHED,UD) have been empowered to compound on payment of Rs. 100/- (Rupees one hundred) for each violation or initiate action under clause 16 of the Arunachal Pradesh Epidemic Disease (Prevention of Covid-19) Regulation, 2020 & under section 188 IPC, if the violator is not agreeing to exercise compounding of the offence.
