CORRIGENDUM IN TENDER REF. NO.196.....DATED 13.02.2020 TO
"INVITATION OF TENDERS FOR PROVIDING
DOOR-STEP DELIVERY (TRANSPORTATION & HANDLING) SERVICES TO THE
FAIR PRICE SHOPS (FPS) LOCATED IN
URBAN AREAS AND BLOCKS OF DIFFERENT DISTRICTS OF JHARKHAND
2020-2022".

This is in response to the queries raised in the Pre-Bid meeting held from 20.02.2020 to 25.02.2020 in the different Districts of Jharkhand for providing "Door Step Delivery (Transportation and Handling) Services to the Fair Price Shops (FPS) located in Urban Areas and Blocks of different districts of Jharkhand 2020-22"

1. Clause 17.3 "The average annual turnover of the Tenderer for the last three financial years namely 2016-17, 2017-18 and 2018-19 shall be

Rs. 1.5 Crore in case the Tenderer is exclusively carrying on the business of transportation goods.

Or

In case Transportation of goods is one of the businesses of the Tenderer, at least Rs. 1.5 Crore of the turnover shall be due to Transportation business."

To be read as

"The average annual turnover of the Tenderer for the last three financial years namely 2016-17, 2017-18 and 2018-19 shall be -

Rs 1.0 Crore in case the Tenderer is exclusively carrying on the business of transportation goods.

Or

In case transportation of goods is one of the businesses of the Tenderer, at least Rs 1.0 Crore of the turnover shall be due to transportation business."

2. Clause 3.1.1. "Making available the sufficient number and type of vehicles at the premises of the Depot / Godowns as requisitioned by the DSO so that the Transportation & Handling work should get completed within 12 days of a month."

To be read as

"Making available the sufficient number and type of vehicles at the premises of the Depot / Godowns as requisitioned by the DSO so that the Transportation & Handling

work should get completed within 12 working days of a month."

3. Clause 8.6 "The Service Provider should be in a position to deploy adequate number of Vehicles for transporting stocks of Food grains (Rice/Wheat/Salt/Sugar) as directed by the DSO within 12 days of the Month. Particulars of Vehicles deployed by the Service Provider (like vehicle registration number, etc.) shall be declared beforehand to the DSO and vehicles should have GPS installed in it. Vehicles not declared as aforesaid shall not be deployed for transportation. Due to any unforeseen reason if the vehicle deployed is not declared prior to deployment, same shall be promptly intimated to DSO on the date of deployment in writing/by e-Mail."

To be read as

"The Service Provider should be in a position to deploy adequate number of Vehicles for transporting stocks of Food grains (Rice/Wheat/Salt/Sugar) as directed by the DSO within 12 working days of the Month. Particulars of Vehicles deployed by the Service Provider (like vehicle registration number, etc.) shall be declared beforehand to the DSO and vehicles should have GPS installed in it. Vehicles not declared as aforesaid shall not be deployed for transportation. Due to any unforeseen reason if the vehicle deployed is not declared prior to deployment, same shall be promptly intimated to DSO on the date of deployment in writing/by e-Mail"

4. Clause 10.2 "Transport Agent will arrange for good condition and sufficient number of vehicles for the received transportation schedule. The Number of Vehicles should be sufficient enough for transportation of the Monthly allotment to Door Step of Fair Price Shops (FPS) within 12 days of the month. The arrangement of vehicles should not be on ad-hoc basis. It should be either OWNED or LEASED by the Transport Agent. In case of Leased Vehicles, the Lease agreement should be valid for 2 years (i.e. during the tenure of this Tender)"

To be read as

Transport Agent will arrange for good condition and sufficient number of vehicles for the received transportation schedule. The Number of Vehicles should be sufficient enough for transportation of the Monthly allotment to Door-Step of Fair Price Shops (FPS) within 12 working days of the month. The arrangement of vehicles should not be on ad-hoc basis. It should be either OWNED or LEASED by the Transport Agent. In case of Leased Vehicles, the Lease agreement should be valid for 2 years (i.e. during the tenure of this Tender)

5. Clause 19.10 "A description note of Fixed & Movable Asset issued by Sub-Divisional Officer, which at least should have value of more than Rupees Seventy Five lakhs and should be issued post publication of the tender to be considered valid. Alternatively, a Bank Guarantee of the same value could also be submitted by the Bidder in favor of District Supply Officer (Payable at Districts name), Jharkhand".

To be read as

"A description note of Fixed & Movable Asset issued by Sub-Divisional Officer, which at least should have value of more than Rupees Fifty lakhs and should be issued post publication of the tender to be considered valid. Alternatively, a Bank



Guarantee of the same value could also be submitted by the Bidder in favour of District Supply Officer(Payable at Districts name), Jharkhand"

6. Clause 19.15 is added and to be read as

"All those Transport and Handling Service contractors who have been registered under MSME for Transport work in the State of Jharkhand will be eligible to get the benefits under the Jharkhand Procurement Policy 2014. In case of MSME registered participants, Attested copy of MSME registration Certificate duly verified by GM, DIC/MD, Industrial Area Development Authority/ Director, Industries, Govt should be uploaded on <https://memberdocs.neml.in>."
