


Order

Whereas Lockdown has been imposed in the Territorial jurisdiction of the District Panchkula, on account of the outbreak of the COVID-19 as pandemic by the WHO, and Sh. Mohamad Yamin 18 years, a resident of Village Khudabakas, Panchkula and Sh. Kalu Khan, aged 80 years, found at Khudabakas, Panchkula has tested positive for COVID-19.

In view of guidelines/Advisories issued by Government the area of Khudabakas, Panchkula has been contained as a Containment Cluster and necessary action is ordered to be taken by creating the Containment Zone and buffer zone.

For carrying out aforementioned orders following authorities are directed to carry out the directions as following:-


1. **Deputy Commissioner of Police, Panchkula:-** will ensure to deploy sufficient Police force to restrict the entry and exit of persons in the Containment Zones and also by way of the putting up Nakas to control the vehicular movements towards the aforesaid Containment Zones.
2. **Civil Surgeon, Panchkula:-** will ensure to deploy sufficient no of teams for conducting door to door screening of persons having SARI/Flu like symptoms throughout the containment zone and will keep the regular surveillance and will also trace all contacts of Smt. Prabha and put them under isolation.
3. **District Development and Panchayat Officer, Panchkula:-** will ensure to sanitize the entire area of each Containment Zone and also depute one official.
4. **District Food and Supply Controller, Panchkula:-** will ensure uninterrupted supply of essential items to and from the containment zone.
5. **XEN, PHED, Panchkula:-** will ensure the supply of drinking water in the containment zone.
6. **XEN,UHBN, Panchkula/ XEN, HVPNL, Madanpur:-** will ensure the sufficient supply of electricity in containment zone.
7. **Deputy Director, Animal Husbandry and Dairying, Panchkula:-** will ensure the sufficient supply of fodder for the animals in containment zone.
8. **Sarpanch, Gram Panchyat Village Khuda Bakash:-** will make all necessary arrangements for disposal of solid waste in the village.
