

ORDER

Whereas Lockdown has been imposed in the containment zone in Territorial jurisdiction of the District Panchkula, on account of the outbreak of the COVID-19 as pandemic by the WHO, and Sh. Pradeep Kumar, aged 52 years resident of H.No. 105, Sector 12-A, Panchkula has been tested positive for COVID-19.


In view of guidelines/advisories issued by Ministry of Home Affairs, Govt. of India vide Order No. 40-3/2020-DM-I(A) dated 01.05.2020, the boundary of the containment zone has to be defined by taking into account the factors - mapping of cases and contacts, geographical dispersion of cases and contacts, area with well demarcated perimeter, and enforceability. Therefore the perimeter of the containment zone is defined as under.

The areas of H.No. 102 to House No. 106, Sector 12-A, Panchkula

The areas enclosed within the aforementioned perimeter are ordered to be contained as Containment Zone and along with buffer zone surrounding aforementioned areas. The Civil Surgeon, Panchkula is further directed to identify the perimeter of the buffer zone.

For carrying out aforementioned orders following authorities are directed to carry out the directions as following:-

1. **Commissioner, Municipal Corporation, Panchkula**-will ensure to sanitized the entire area of containment zone and buffer zone and also will make all necessary arrangements for disposal of solid waste in the respective area.
2. **Deputy Commissioner of Police, Panchkula**- will ensure to deploy sufficient Police force to restrict the entry and exit of persons in the containment zone as well as buffer zone and also by way of the putting up Nakas to control the vehicular movements towards the aforesaid Containment Zone.
3. **Civil Surgeon, Panchkula**-will ensure to deploy sufficient nos. of teams for conducting door to door screening of persons having SARI/Flu like symptoms throughout the containment zone and buffer zone and will keep the regular surveillance and also trace all contacts (backward & forward) of Sh.Pardeep Kumar and put them under isolation.
4. **District Food and Supply Controller, Panchkula**- will ensure uninterrupted supply of essential items to and from the containment zone.
5. **XEN, PHED, Panchkula**-will ensure the supply of drinking water in the containment zone.
6. **XEN, UHBVN, Panchkula** -will ensure the sufficient supply of electricity in containment zone.
7. **Estate Officer, HSVP, Panchkula**- will be overall in-charge for the aforementioned containment zone and Sh. M.P. Sharma, SDE, HSVP, Panchkula will assist her.


