DECLARATION UNDER SECTION 19 OF THE ACT

WHEREAS, under sub-section (1) of Section 11 of the Right to Fair Compensation and Transparency in Land Acquisition Rehabilitation and Resettlement Act, 2013, Notification No.1972 dated 26.08.2019 in respect of the land specified in the schedule below has been published.

AND WHEREAS, the appropriate Government is satisfied after considering the report made by the Collector under sub-section (1) of Section 15 of the Right to Fair Compensation and Transparency in Land Acquisition Rehabilitation and Resettlement Act, 2013, that the land specified in the schedule below has to be acquired for a public purpose.

Now, THEREFORE the District Collector, Kollam hereby declares under Section 19 of the Act, that the land specified in the Schedule below and measuring 0.0073 hectares 00.73 Ares to be the same, a little more or less, is needed for a public purpose, to wit for the widening of Punalur – Moovattupuzha Road at Pathanapuram village and direct the Special Tahsildar, LA No.1, Kollam to take order for the acquisition of the land.

A plan of the land is kept in the Office of the Special Tahsildar, LA No.1, Kollam and may be inspected at any time during office hours.
