In exercise of the powers conferred by 2nd proviso to subsection 7 of section 19 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Central Act 30 of 2013), the Government of Kerala hereby extent the time limit in publishing the declaration as per sub-section 1 of section 19 to the Notification issued under sub-section (1) of section 11 as per Proceedings No C-342/08 dated 2nd August 2019 and published in the Kerala Gazette Extraordinary No. 2009 dated 29th August 2019, namely:-

Extension

Proceedings No C-342/08 dated 2nd August 2019 has been issued in accordance with the provisions of sub-section (1) of section 11 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 with regard to the acquisition of 6.45 ares of land in Paravoor Village for the construction of Public Market for Chirakkara Grama Panchayat.

AND Whereas, the District Collector, Kollam has reported that as per Section 19(7) of LARR Act, 2013 the 19(1) Declaration has to be published within 12 months from the date of issuance of 11(1) Notification (preliminary notification) and that the 11(1) Notification issued as per Proceedings No C-342/08 dated 2nd August 2019 expired by 02/08/2020. It has been informed that due to the delay in finalizing the objections placed by the landholders on the 11(1) Notification, 19(1) Declaration could not be published in time and requested to extend the time limit in publishing the 19(1) Declaration.

Now THEREFORE, sanction is accorded to extend the time limit in publishing the declaration for a further period of 6 months from the date of expiry of the 11(1) Notification ie, 02/08/2020 by invoking the provisions contained in 2nd proviso to Section 19(7) of the LARR Act, 2013 with regard to the acquisition of 6.45 Ares of land in Paravoor Village for the construction of Public Market for Chirakkara Grama Panchayat.

Explanatory Note

Proceedings No. C-342/08 dated 2nd August 2019, has been issued in accordance with the provisions of sub-section (1) of section 11 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 with regard to the acquisition of 6.45 Ares of land in Paravoor Village for the construction of Public Market for Chirakkara Grama Panchayat. As per Section 19(7) of LARR Act, 2013, the 19(1) Declaration has to be published within 12 months from the date of issuance of 11(1) Notification (preliminary notification) and that the 11(1) Notification issued as per Proceedings No C-342/08 dated 02/08/2019 expired by 02/08/2020 and therefore extend the time limit for publishing the 19(1) Declaration.

The notification is intended to achieve the above object.
