DECLARATION

WHEREAS, it was notified by the Government of Tripura in Revenue Department vide Notification No. F.09 (02)-REV/ACQ/XIII/19, dated 25-01-2021, that the land/lands measuring 0.07 acres as described in the schedule hereto (hereafter referred to as said land/lands) was/were needed or likely to be needed for the public purpose namely for the purpose of construction of new railway line from Agartala to Sabroom under Sabroom Sub-Division in South Tripura District.

AND WHEREAS, the Government of Tripura is satisfied, on the basis of the observation made by the Administrator of the concerned District that the Rehabilitation and Resettlement Scheme shall not apply under the provision of sub-section 2 of section 17 of "the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013" (hereinafter referred to as "the Land Acquisition and Rehabilitation Act"), because no displacement of family /families will occur due to proposed acquisition process.

AND WHEREAS, the requiring body has deposited the cost of land to be acquired with the concerned Collector;

NOW THEREFORE, it is hereby declared under the provision of Section 19 of the Land Acquisition and Rehabilitation Act that the land/lands is/are required for the public purpose, namely for the purpose of construction of new railway line from Agartala to Sabroom under Sabroom Sub-Division in South Tripura District.

The Government is also pleased to direct the Collector, West Tripura District under Section 20 of the said Act to proceed with works.

The Land Statement and Plan may be inspected in the office of the Collector, South Tripura District during office hours.


