ORDER:

In the circumstances explained by the Director of Agricultural Marketing, Hyderabad in the letter 2nd read above, and Government after careful examination of the matter, hereby accord permission to the Director of Agricultural Marketing, Hyderabad to operate the procurement centres at Market Yards, Sub- Market Yards and NABARD Godown points on par with IKP / PACS, so as to earn commission as source of income to augment the loss of market fee in the TRADE AREA to get sufficient income for payment of salaries to the Staff of Agricultural Market Committees, Central Market Fund Employees, dependent Outsourcing Employees and the Pensioners. Further, the Director of Agricultural Marketing, Hyderabad is directed to issue necessary operational guidelines to the Agricultural Market Committees in the State to operate the procurement centres at Market Yards, Sub- Market Yards and NABARD Godown points on par with IKP / PACS.

The State Nodal Agencies i.e., Vice Chairman & Managing Director, Telangana State Civil Supplies Corporation Ltd., Managing Director, Telangana State Cooperative Marketing Federation Ltd., (TS MARKFED), Managing Director, Hyderabad Agriculture Cooperative Association Limited (HACA) and Managing Director, Telangana State Cooperative Oilseeds Growers Federation Limited (OILFED) are directed to allot the procurement centers to Market Yards, Sub- Market Yards and NABARD Godown points on par with IKP / PACS.

3. The Director of Agricultural Marketing, Hyderabad shall take necessary action in the matter accordingly.
