2. The functions of the District Level Committee are :-

1. Regulate the arrivals of cotton in market yards by specifying the days for a particular area or assigning a geographical area to the market yard.
2. Monitor price movements of cotton;
3. Decide number and location of purchase centers of Cotton Corporation of India.
4. Assess infrastructure facilities and bridge gaps
5. Ensure prompt payment to farmers
6. Ensure prompt lifting of stock from the market yards
7. Resolve any disputes arising out MSP operations among stakeholders.

3. The committee shall meet once in a week or more frequently based on need.
