OFFICE ORDER

NO. 2053 /EMG. DATE 05-09-2020

Whereas Govt. of Odisha in exercise of powers conferred under section 2, 3 & 4 of the Epidemic Diseases Act, 1897 has promulgated Odisha COVID-19 Regulations, 2020 for containment of COVID-19.

And Whereas, the National Disaster Management Authority, Govt. of India in exercise of powers conferred under section 6(2) (i) of the Disaster Management Act, 2005 has directed the State Government/ State Authorities to take measures for ensuring social distancing so as to prevent the spread of COVID-19 and directed the National Executive Committee under the said Act to issue necessary guidelines in this regard.

And Whereas, Govt. of Odisha has issued various measures to contain the spread of COVID-19 vide order No. 2035/R&DM, dated, 27.03.2020.

And Whereas, positive cases of COVID-19 have been detected in the village-Champapur(Gadbhitar) of Champamal GP & Laturpet(Harijanpada) of Hilung GP under Birmaharajpur Block which requires detailed measures for active contact tracing & surveillance. Since 06 nos. & 40 nos. of households are residing in these villages respectively, it is necessary to declare these areas as containment zones to restrict public from entering into and going out of these areas in order to prevent any further spread of COVID-19 cases.

Now, therefore in larger public interest and with a view to contain the spread of COVID-19 I, Mrs. Monisha Banerjee, IAS, District Magistrate & Collector, Subarnapur and the Empowered Officer hereby direct to implement the following directions.


- a. The following area as indicated below are declared as containment zones.

Champapur(Gadbhitar) of Champamal GP	Laturpet(Harijanpada) of Hilung GP
<p>i. Gadbhitar Basti in the East. ii. Champapur-Champamal road in the West. iii. Gadbhitar road in the North.</p>	<p>i. Harijanpada Basti in the East. ii. Laturpet-Thenga Dam in the West. iii. Vacant space in the North & South.</p>

- The indicative Sketch Maps of the areas are enclosed for reference.
- b. All vehicular movement and personal movement will be stopped within the containment areas.
- c. All the inhabitants within the containment zone shall strictly remain in home. All the shopping establishment of whatsoever nature shall be closed immediately. The supply of essentials and medical requirement will be ensured through various teams formed by the District Administration.

- d. The following officers are hereby declared as the Nodal Officers to ensure smooth supply of essentials/ facilities in respect of the containment zone.

 - v. Sri Ashok Kumar Bhoi, OAS(SB),
Sub-Collector, BMPur (9437393596) Overall supervision.

This order comes into effect immediately and it will be in force until further orders.





VILLAGE - CHAMPAPUR (GADDBHITAR)

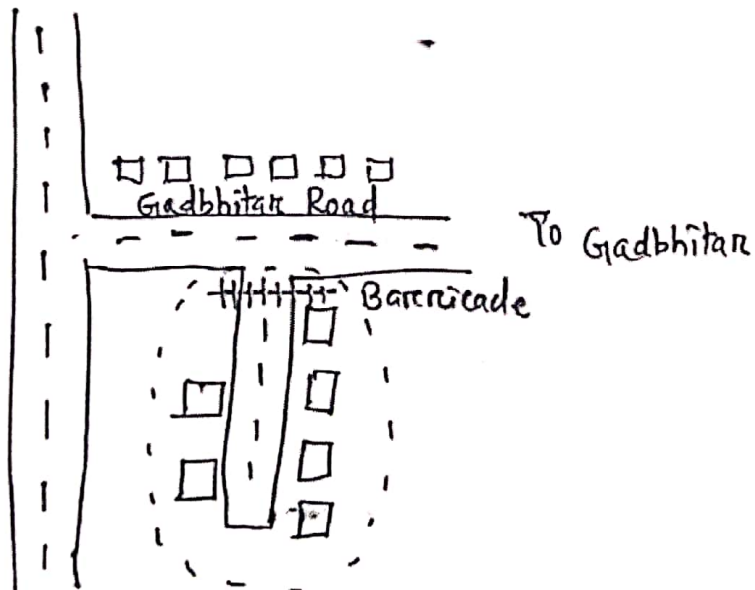
