NOTIFICATION

Whereas some persons from Mahabari Gram Panchayat under Banshihari Development Block area within the district of Dakshin Dinajpur had direct contact with COVID positive zone and the suspected were put into Quarantine Centre and samples were taken on 05.06.2020 for testing of COVID-19 infection;

AND

Whereas such persons had shown positive results for COVID-19 infection and the results of test were issued on 14.06.2020;

AND

Whereas the areas falling within the residential perimeter of such COVID-19 positive cases where the persons might have come in direct contact with family members and others, and these primary and secondary contacts of COVID-19 positive cases are residing in the village of Patharghata, Mouza – Panjaripara and Mahabari, P.O. Sudarshannagar, Polling Station-192- Haveli ICDS (Part) & 194- Sudarshannagar GSFP (Part), PS – Banshihari, Dist. Dakshin Dinajpur is hereby declared as Containment Zone for the purpose of taking special steps for containment of further spread of infection;

AND

Whereas house-to-house survey is to be done thoroughly and all ILI / SARI patients from these Containment Zones are to be tested for COVID-19 infection as per S.O.P.

Hence, the area as mentioned in following table (**Table-A**) is hereby declared as **Containment Zone ('A' Category Affected Area)** within the district of Dakshin Dinajpur with immediate effect.

Block Development Officer, Banshihari will ensure strict compliance of order.

Sri Debojit Bose, WBCS (Exe.), is hereby appointed as Incident Commander and he is hereby directed to form a multi-disciplinary team involving Health Professionals, I/C of Police Station, Private Health Practitioners, Public Representatives and other influential people of the area. He shall also submit a weekly report to the undersigned touching upon various issues relating to the Containment Zone like number of COVID-19 tests conducted within the specified area, positivity rate, distribution of essential commodities/services, law and order situation, and other such matters the Incident Commander would like to bring to the notice of the undersigned.
