The undersigned will not be responsible for rejection of the tender due to the delay in the postal/courier transit or any other reason. The Sealed Tenders will be opened on 05.02.2021 at 1.00 P.M. in presence of the Artho upo samity members and bidders, who may wish to remain present. Tender Form of works has to be purchased from the Jamalpur Gram Panchayat office at any working day from from 29.01.2021 to 04.02.2021 (from 11.00 PM to 3.00 PM).

Terms & Conditions:-

- Cost of Tender Form (non-refundable) has to be paid in cash (DCR form 5)/Demand Draft only, in favour of The Pradhan, Jamalpur GP.
- Bidders must submit self attested photocopies of the following documents (clause 2.1-2.6)
 - GSTIN No with registration certificate of GST,
 - PAN Card with Last three years Income Tax Return,

- 2.3 Profession Tax Registration Certificate with current challan (as per the West Bengal State Tax on Profession, Trades, Calling & employment, Act 1979)
 - 2.4 Trade Registration Certificate/License of 2020-21 FY.
 - 2.5 Partnership deed in case of partnership firm/Company etc.
 - 2.6 Minimum of 60 % credential of the "Single similar types Compact work", over the tendered amount of last Three (03) years (excluding current FY) (See Annexure A)
3. Earnest money should be deposited in either Cash or Bank Draft in favour of The Pradhan, No-5 Jamalpur Gram Panchayat and will be refunded/forfeited as the case may be. In case of Cash the bidder must collect Misc. receipt from the Gram Panchayat office.
 4. Bidder must submit 2nos. sealed envelope clearly mentioning serial number and name of work on top of the envelope ((1st no. envelope for Technical bidding ,like:- all documents mentioning in terms and condition clause no.2&3) & (2nd no. envelope for Financial bidding, like:- Tender form, Earnest Money & Tender form fee)).
 5. 4. Bidders must quote rates in absolute numerical values and in percentage (both in figures and words) against the tender amount.
 6. Pre-bid conference/meeting with the prospective Bidders will be held on 03-02-2021 at 2 PM. Environmental and Social Safeguards issues pertaining to the tendered work will also be discussed and explained in the meeting.
 7. Multiple bids on same work by the bidders shall be rejected outright.
 8. No special preferences in respect of Earnest Money, Security Deposit etc. will be given to any Cooperative Society/Government owned Company/Government Undertaking/Corporation/ Engineering Cooperative etc. In other words, all participating Bidders will be treated on equal basis only and no favourable/special considerations will be accorded to any bidders.
 9. Rate offered by a bidder in a particular Tender shall be treated as final and subsequent negotiation with that bidder for change in price shall not be allowed.
 10. Security deposit (10% of the total amount of bill), the amount may be deducted from every running payment (not exceeding two including the final bill) made and will be released after 6 months.
 11. GST (2% in work order value above Rs.2,50,000/-, TDS or IT(2%) and Cess(1%) (if any) will be deducted as per existing rates fixed by the respective department of the government.
 12. Site visit may be done by the bidders at their own cost.
 13. Erroneous or incomplete Tender Form will be summarily rejected without assigning any reason whatsoever.
 14. Bidder(s) may be asked to submit rate analysis for items where the quoted rates are either too high or low or same than the estimated cost. Such bids may also be considered as null and void if there is a reason to believe that the Bidders have formed a cartel and rates have been manipulated, unbalanced or unreasonable.
 17. 16. Successful Bidder will have to execute a formal agreement on a Non-Judicial Stamp paper worth Rs. >10/- (Ten) within 3 (Three) working days from the date of receive of "Letter of Acceptance" with the Gram Panchayat wherein the description, specification, quantity, date of completion of work, other mandatory conditions and ESMF (Environmental and Social Management Framework) issues shall be detailed. Failure to execute the contract will lead to automatic cancellation of the bid.
 18. The undersigned is not bound to accept the lowest tender and reserves the right to accept or reject any or all tenders, as the case may be without assigning any reason whatsoever.
 19. Quoted rate shall be inclusive of all charges including royalty, GST, tools charges, transportation charges etc.
 20. Any bid received from the bidder without authentication of correction made in rate quoted in word or figure shall lead to cancellation of the bid.
