The undersigned will not be responsible for rejection of the tender due to the delay in the postal/courier transit or any other reason. The Sealed Tenders will be opened on 30.09.2021 at 1.00 PM. in presence of the Artho Upo Samity members and bidders (who may wish to remain present). Tender Form of above mentioned works has to be purchased at the Panjul Gram Panchayat office from on 24.09.2021 to 28.09.2021 (office hour) & last date 29.09.2021 (upto 3.00 PM).

Terms & Conditions :-

Cost of Tender Form (non-refundable) has to be paid through RTGS/NEFT/ONLINE TRANSFER/BY CASH DEPOSIT from any nationalized bank in favour of "THE PRODHAN, No.2 PANJUL GRAM PANCHAYAT" in the Account No:- 5187101000291 and IFSC Code:- CNRB0005187 (CANARA BANK,Branch:- 5187-PANJUL). The self attested photocopy should be kept in the Financial Bidding Cover.

The Amount of Earnest Money is 2% (Two percent) of the Tender amount in the shape of RTGS/NEFT/ONLINE TRANSFER/BY CASH DEPOSIT from any nationalized bank in favour of "THE PRODHAN, No.2 PANJUL GRAM PANCHAYAT" in the Account No:- 5187101000291 and IFSC Code:- CNRB0005187 (CANARA BANK,Branch:- 5187-PANJUL). The self attested photocopy should be kept in the Financial bidding Cover.

Bidders must submit self attested photocopies in the **Technical Bidding Cover** (Valid GSTIN Registration Certificate, PAN Card Copy, Latest 3years (18-19, 19-20, 20-21) Income Tax Return, Profession Tax Registration Certificate with Current Challan and Latest year Trade Registration Certificate/License from local bodies as the case may be. They should also submit self attested photocopies of Work Order copy, Completion Certificate copy and Payment Certificate / Credential copy in similar nature of work during last 3 year (Minimum Financial Year Accepted 2018-19) from the date of issue of notice for proofing credential submitted as previous) and in the **Financial Bidding Cover** enclosing Tender form, Earnest Money & Tender form fee.

Bidder must submit **2 nos. sealed envelope with clearly mentioning NIT No. & serial number & Cover name Technical/Financial on top of the envelope**. In **Technical bidding Cover** enclosing all documents mentioning in terms and condition clause no.3 & in **Financial bidding Cover** enclosing Tender form, Earnest Money & Tender form fee.

Bidders must quote their rates in **absolute Percentage basis (both in figures and words)** against the tender amount.

No special preferences in respect of Earnest Money, Security Deposit etc. will be given to any types of Engineering Co-Operative Society/Govt. owned Company/Govt.Undertaking/Corporation/Cooperative etc. In other words, all participating Bidders will be treated on equal basis only and no favourable/special considerations will be accorded to any bidders. In case of **Labour Cooperative must Submit the Latest Govt.Order** for not taking of any type Earnest Money/Security Deposit.

Rate offered by a bidder in a particular Tender shall be treated as final and subsequent negotiation with bidder for change in quoted price or withdrawn of bid from any stage shall not be allowed. Otherwise the Earnest money of this Bidder/Agency may forfeited by the undersigned.

Security deposit should be deducted from every running payment (not exceeding two including the final bill) made and will be released after 6 months after checking the spot.

CGST & SGST (1+1)% in work order value above Rs.2,50,000/-, TDS or IT(2 or 1%) and Cess(1%) (if any) will be deducted as per existing rates fixed by the respective department of the government.

Site visit may be done by the bidders at their own cost.

Erroneous or incomplete Tender Form will be summarily rejected without assigning any reason whatsoever.


Bidder(s) may be asked to submit rate analysis for items where the quoted rates are either too high or low or same than the estimated cost. Such bids may also be considered as null and void if there is a reason to believe that the Bidders have formed a cartel and rates have been manipulated, unbalanced or unreasonable.

Successful Bidder will have to execute a formal agreement on a Non-Judicial Stamp paper (Rs. 10/- or Higher) within seven days from the receipt of "Letter of Acceptance" with the Gram Panchayat wherein the description, specification, quantity, date of completion of work, other mandatory conditions. Failure to execute the contract will lead to automatic cancellation of the bid.

The undersigned is not bound to accept the lowest tender and reserves the right to accept or reject any or all tenders, as the case may be without assigning any reason whatsoever.

Quoted rate shall be inclusive of all charges including royalty, GST, tools charges, transportation, carriage Charge etc.
