Notice Inviting Tender

Sealed tenders are hereby invited from the bona fide/reputed and experienced contractors to submit the rates for lifting of different type waste papers from the Govt. Offices of the district of Dakshin Dinajpur

1) The rates of different type waste papers should be quoted both in figures and words inclusive of all taxes. The tenders should quote the rates in the pad mentioning the name of their agency. The tender must avoid over writing the form of tender.

2) Copies of latest P.Tax, GST, Trade licence, PAN Card, Credential certificate are required to be attached with the tender.

3) Tenderers shall have to deposit an earnest money worth of Rs.10,000/- (Rupees ten thousand) only in favour of the District Magistrate, Dakshin Dinajpur by way of A/C payee bank draft on any nationalised bank payable at SBI, Balurghat Branch. Earnest money so deposited shall be converted into security money in respect of successful tenderers.

4) The tender should be submitted in sealed envelope super scribed with "Tender for lifting of waste paper from the Government offices of the district of Dakshin Dinajpur from time to time and addressed to the District Magistrate, Dakshin Dinajpur and it should be dropped in drop box kept in the office chamber of the Officer-in-Charge, General Section, Dakshin Dinajpur located at 1st floor of the Administrative Buildings, Dakshin Dinajpur.

5) Last date of submission of tender has been fixed on **22. 11. 2021** upto 2.00 pm and the tender box will be opened on the same date i.e on **22. 11. 2021** at 04.00 pm in presence of the tenderers or their authorised representatives at the official chamber of the Addl. District Magistrate(Gen.), Dakshin Dinajpur. Any tender received beyond the scheduled date and time shall not be entertained under any circumstances. No conditional tender will be entertained.

6) The tender may also be sent through registered post/speed post/which must reach within the prescribed time frame.

7) The successful tenderers will have to make an agreement with the undersigned on a Non-judicial Stamp Paper worth of Rs. 10/- (Rupees ten) only. The security deposit maybe refunded to the tenderer whose tender is not accepted & considered in due course.


8) The undersigned deserves the right & discretion to terminate the contact and forfeit the earnest money deposited in the event of any sort of breach of contact.


9) The undersigned deserves the right to accept or reject any tender at any time without assigning any cause/reason whatsoever.
