Encrypted electronic bids are hereby invited by the Proddhan. No. 5 Bhatpara Gram Panchayat through a single stage two part e-Procurement System; (Part I: Techno-commercial bid and Part II: Financial bid) for the 'LIST OF WORKS' given below from eligible bonafied contractors/agencies/bidders having specified Pre-Qualification (eligibility) credential for execution of works of similar nature and desired financial capabilities. The technical bid in Part-I would require the bidder to qualify for the next phase of financial bid: Part-II, in which L1 bid price would determine the final selection and acceptance of a bidder for award of the Procurement of Goods & Works contract.

Intending contractors/bidders desirous of participating in this e-Tender are required to login to the Government of West Bengal e-Procurement website having URL <https://wbtenders.gov.in>, or by logging-in using their assigned User ID and password. They may also visit the official website having URL [www.ddinajpur.nic.in](http://www.ddinajpur.nic.in) to locate the same e-Tender.

The interested bidders eligible for the tender are required to submit their bids through the e-Procurement System using their valid DSC eToken with assigned PIN using login ID and password.

(i) It is desirable that all documents stated above in PDF files shall be uploaded by bidders only in specified designated name.

**No off-line document will be accepted and considered during tender evaluation stage from bidders.**

(ii) If the State Registered Co-operative Societies was set up less than three years ago, audited balance sheets and P/L Accounts for the number of years since inception are to be submitted under Technical cover and the average value would be evaluated only for the period since inception and not three years.

(iii) No file in Technical / Pre-Qual cover or OID cover folder is allowed by the system to be kept blank/empty. Where ever the forms and documents are uploaded by the Proddhan, on behalf of Artho – O – Parikalpana Upasamity, the same is to be downloaded, duly filled up, converted to pdf file, and again uploaded, forming a part of tender document. Relevant blank Forms are to be firstly downloaded by the bidders from the NIT in e-Procurement portal, filled up completely and again uploaded with their electronic bid.

- (i) Bill of Quantities (BOQ): The contractor/bidder is required to quote the financial offer/bid price or rate as percentage above or below the estimated amount put to tender or 'at par' with tender value, in the space marked for quoting rate in the BOQ of the tendered work.
- (ii) Only the downloaded sheet of the above document in Excel format is required to be uploaded by the contractor/bidder.
- (iii) BOQ without a valid numeric rate at the designated space provided in the BOQ will be disqualified and rejected outright. Contractors/bidders willing to quote "at-par" rate shall need to write "0" in the 'space' provided for rates in the BOQ of the tendered work.

#### Annexure-B

#### Terms & Conditions:-

1. The Tender Fee has to be paid through RTGS/NEFT from the bidder's own account from any nationalized bank in favour of The Proadhan, No. 5 Bhatpara Gram Panchayat in the Account No. 1977010015978, IFSC - UTBIQBHQW81 (United Bank of India, Bhushila Branch). The Scan Copy should be uploaded with UTR No. & name of work with sl.no. No other modes are accepted.
2. Earnest Money Deposit (EMD) has to be paid through RTGS/NEFT from the bidder's own account from any nationalized bank in favour of The Proadhan, No. 5 Bhatpara Gram Panchayat in the Account No. 1977010015978, IFSC - PUNB0197720 (PUNJAB NATIONAL BANK, Bhushila Branch). The Scan Copy should be uploaded with UTR No. & name of work with sl.no. No other modes are accepted.

If the bidder is exempted from payment of EMD by the State Finance Department, the Govt order for such exemption is to be uploaded while opting for EMD exemption category. Any misjudgment and resultant non submission of EMD will lead to rejection of the bid. However, all other PQ credentials are to be fulfilled by each bidder.
3. Bidders must submit self attested photocopies of valid Trade License from local bodies, GSTIN registration, PAN, latest three years Income Tax Return [ie. 18-19, 19-20 & 20-21] and Profession Tax Clearance Certificate with current challan and Trade Registration Certificate/License from local bodies for current financial year or Government Order for exemption in other States where ever applicable. Registered Unemployed Engineers' Co-operative Societies/ Unemployed Labour Co.- Op. Societies are required to furnish valid Bye Law, Current Audit Report, Valid Clearance Certificate from A.R.C.S. for the year 2020-2021. The partnership firm is required to furnish copy of Registered Partnership Deed. A Company shall furnish the Article of Association and Memorandum.
4. Bidders must submit self attested photocopies of Work Order, Completion Certificate and Payment Certificate / Credential Certificate in similar nature of work during last 3 years from the date of issue of notice for proofing credential submitted as previous.
5. In case of bid/tender emanating from cartelization of bidders, entire tender process will be cancelled.
6. Bidders must quote rates in Percentage Basis in the BOQ.
7. Rate offered by a bidder in a particular Tender shall be treated as final and subsequent negotiation with that bidder for change in price shall not be allowed.
8. Multiple bids (more than one bid by same bidder) and variable rates (different rates of same item by same bidder) shall be rejected outright.
9. ~~No special preferences in respect of Earnest Money, Security Deposit etc. will be given to any Co-operative Society/Government owned Company/Government Undertaking/Corporation/ Engineering Cooperative etc. In other words, all participating Bidders will be treated on equal basis only and no favourable/special considerations will be accorded to any bidders.~~
10. Successful Bidder (s) will be required to lodge security deposit (10% of the total value of the work as quoted by him) as performance security in the form of Bank Draft duly pledged in favour of the "Proadhan, No. 5 Bhatpara Gram Panchayat" OR the amount may be deducted from every running payment (not exceeding two including the final bill) made and will be released after 6 months in case of Building, Culvert and Concrete Roads and 3 months in all other cases.
11. GST, TDS and applicable Cess (if any) will be deducted as per existing rates fixed by the respective department of the Government.
12. Site visit may be done by the bidders at their own cost.
13. Erroneous or incomplete Tender Form will be summarily rejected without assigning any reason whatsoever.
14. Bidder(s) may be asked to submit rate analysis for items where the quoted rates are either too high or low than the estimated cost. Such bids may also be considered as null and void if there is a reason to believe that the Bidders have formed a cartel and rates have been manipulated, unbalanced or unreasonable.
15. Successful Bidder will have to execute a formal agreement on a Non-Judicial Stamp paper of Rs. 10.00 (Rupees Ten only) within seven days from the receipt of "Letter of Acceptance" with the Gram Panchayat wherein the description, specification, quantity, date of completion of work, other mandatory conditions and ESMF (Environmental and Social Management Framework) issues shall be detailed. Failure to execute the contract will lead to automatic cancellation of the bid.
