3. Eligibility criteria for participation in tender:

- The prospective bidders shall have satisfactorily completed as a prime agency during the last 5 (five) years prior to the date of issue of this Notice at least one work under authority of State/Central govt., Central/State Government undertaking/Statutory Bodies and having past credentials (payment) certificate 40%(forty percent) of the estimated amount put to tender. Payment certificate to be submitted along with completion certificate of the respective work.
- ii) Valid P.tax,trade license, pan card, GST registration certificate along with up to date GSTclearance challan and Income tax clearance certificate for the latest Assessment year to be accompanied/scanned with the technical bid documents.

iii) The intending tenderers must submit Electrical Contractors License for electrical work.

Registered Unemployed Engineers' Co-operative Societies/Unemployed Labour Co-operative Societies are required to furnish Current Audit Report, along with other relevant supporting papers.

v) Joint Ventures will not be allowed.
