

ORDER UNDER SECTION 144 OF THE CODE OF CRIMINAL PROCEDURE, 1973

Whereas it has been made to appear to me that there is likelihood of causing tension annoyance, obstruction or injury to person, danger to human life & property, disturbance of public peace and tranquility within the limit of Examination centers on account of conducting the Examination by the Kurukshetra University to be held on **01.04.2019 to 04-04-2019** in colleges of District Kaithal.

Whereas, it has been made to appear to me that the gathering of the five or more persons is likely to cause obstruction in the maintenance of peace and tranquility within the area of about 200 meters around the Examination centers in Kaithal District.

Now, therefore, in exercise of the powers vested in me by virtue of section 144 of code of Criminal Procedure, 1973. **I, Dr. Priyanka Soni, I.A.S, District Magistrate, Kaithal** do hereby prohibit the gathering of the five or more person in the area of 200 (two hundred) meters around the Examination centers in Kaithal District during the period of exam i.e **02:00 pm to 05:00 pm from 01.04.2019 to 04-04-2019** Photo-state business is banned only during the Examination duration i.e **evening session 02:00 pm to 05:00 pm** on the day of examination in the area of 200 meters around the Examination centers mentioned below in the District Kaithal.

Due to emergent situation, this order is being passed ex-parte. For the violation of the aforesaid order, if any person found guilty, he will be liable for punishment under section, 188 of the Indian Penal Code.
