

ORDER


Whereas it has been made to appear to me that tension is prevailing in the area of Kaithal District on account of General Election to the Lok Sabha, 2019. As per the guidelines of ECI the general order U/s 144 Cr.P.C. are issued regarding ban on unlawful assemblies and prohibition on holding of public meeting during the period of 48 hours ending with the hour fixed for the close the poll, applicable for the areas constituencies bounded for polls. The restriction under this Cr.P.C order do not permit more than five person to assemble/move together in the area. However, the Commission has clarified that this does not restrict house to house visiting during 48 hour in connections with door to door campaigning And whereas I am further satisfied that directions issued by ECI is mandatory to enforce to avoid any disturbance during Lok Sabha Election of public tranquility or riot or affray.

Now therefore, in exercise of the powers vested in me by virtue of section 144 of the code of Criminal Procedure 1973, **I, Dr. Priyanka Soni, I.A.S, District Magistrate, Kaithal** do hereby prohibit holding of public meeting during the period of 48 hours ending with the hour fixed for the close the poll, applicable for the areas constituencies bounded for polls and do not permit more than five person to assemble/move together for campaigning in the constituency area of Kaithal district.

This order shall be promulgated throughout the district by beat of drum, by announcement through the publicity van of Public Relation Department and by affixing the copies of this order on the notice board of District, Sub Divisional and Tehsil Courts, Public places as well as Police stations located in Kaithal District.

For the violation of the aforesaid order. if any person found guilty. he will be liable for punishment under section 188 of the Indian Penal Code.


