

**ORDER UNDER SECTION 144 OF CODE OF CRIMINAL PROCEDURE, 1973**

Whereas it has been made to appear to me that China Dori/Thread or any other synthetic material which is being used for flying kites is very dangerous to human life/property and resulting in accidental death either by touching the high voltage wire etc. or otherwise.

Whereas, it has been made to appear to me that there is need to ban and it has become necessary to stop this storage, sale and purchase of China Dori/Thread or any other synthetic material which is being used for flying the kites within the limits of district Kaithal and I am satisfied that directions are necessary to be issued in this regard.


Now, therefore, in exercise of the powers vested in me under Section 144 of Code of Criminal Procedure, 1973, **I, Dr. Priyanka Soni, I.A.S District Magistrate, Kaithal** do hereby prohibit the storage, sale and purchase of China dori/thread or any other synthetic material which is being used for flying the kite within the limits of district Kaithal for the period of three months from today. The Superintendent of Police, Kaithal shall ensure the compliance.

This order shall come into force with immediate effect.

This order shall be promulgated in the district Kaithal by beat of drum, announcement through van of Public Relation Department, by affixing the copy of this order on the notice board of District Courts, Sub Divisional and Tehsil Courts, Municipal Committee Office, Railway Station and other public place as well as in Police Stations.

For the violation of the aforesaid order, if any person is found guilty, he will be liable for punishment under Section, 188 of the Indian Penal Code.


