

ORDER UNDER SECTION 144 OF THE CODE OF CRIMINAL PROCEDURE, 1973

Whereas it is expedient to maintain public peace and order during counting of votes for the General Election to Haryana Vidhan Sabha, 2019 at the following counting centers:-

15-Guhla (SC)	D.A.V. College Hall, Cheeka
16-Kalayath	Auditorium Hall, I.G, (P.G), College, Karnal Road Kaithal
17-Kaithal	R.K.S.D. (P.G), College Hall Kaithal
18-Pundri	Common Room, I.G, (P.G), College, Karnal Road Kaithal

1. Whereas, it is likely that during poll process on 21.10.2019 storage of Electronic Voting machines counting of votes and declaration of results of election, the atmosphere can be highly charged and there is every possibility of law & order situation being disrupted by any procession, jubilation or other such acts.

2. Considering all these exigencies, I am of the opinion that taking out processions or assembly of 5 or more people is likely to cause obstruction of public order and tranquility or possibility resulting in a riot or an affray.

3. And whereas I am satisfied that directions are necessary to prevent obstruction or injury to persons lawfully employed or risk or danger to human life, health or safety of property or a disturbance of the public tranquility of a riot or an affray.


4. Now therefore, in exercise of the powers vested in me by virtue of section 144 of the code of Criminal Procedure 1973, **I, Dr. Priyanka Soni, I.A.S, District Magistrate, Kaithal** do hereby prohibit as a measure of precaution for maintenance of public peace and order procession or assembly of 5 or more persons within radius of 300 meters of the counting places in Kaithal district. I further prohibit as a measure of precaution of carrying of any explosive substance, fire arm or any other weapon of offence like Gandasa, Kirpan, Knives, Kulhari, Spear ballam, Jeli, Lathi, Cycle Chain and any other thing capable of being used as a weapon of offence or other inflammable material within 500 meters of counting places during the period from 20.10.2019 to 24.10.2019.

This order shall not apply to police and other public servants on election duty.

In view of the emergent situation and shortage of time, this order is being passed ex-parte and is addressed to the public in general.

This order shall promulgated throughout the Kaithal district by announcement through the publicity van of Public Relation Department and by affixing copies of the Notice Boards of the District Court, Sub Division Courts and other public places as well as Police Stations.


