Whereas it has been made to appear to me that flying Drone is very dangerous, resulting in accident death either by touching the high voltage wires and criminal activities etc. The Drone in all likelihood may cause obstruction or injury to any person and danger to human life and property further by use of drone the percurring of images of individual house hold, girls hostel is disclosure of their personal activities & moment/information which may lead to serious law and order problem in the district.


Whereas, it has been made to appear to me that there is a need for restriction of the flying Drone which is dangerous to animals, birds, human life and kind of criminal activities.

Now, therefore, **I, Sujan Singh, I.A.S, District Magistrate Kaithal** in exercise of the powers vested in me by virtue of section 144 of the Code of Criminal Procedure, 1973, do hereby prohibit the flying Drone, remote controlled aircrafts, flying camers, coward copter, helicam, aercial coverage without any permission in district Kaithal.

This order shall be promulgated in area of Kaithal district by beat of drum, by announcement through the publicity van of Public Relation Department and by affixing of the copies of this order on the notice boards of District Courts/ Sub Division/Tehsil Courts/Police Stations etc.

In view of requirement of the situation which has become emergent, this order is passed ex-parte and is addressed to the public at large.
