

ORDER

World Health Organization (WHO) has declared the recent Novel Corona Virus (COVID-19) epidemic as Public Health Emergency of International Concern (PHEIC). The Civil Surgeon, Kaithal has reported that the foreigners/travelers are coming from different countries will be kept in quarantine facility at containment unit.
