

Whereas it has been made to appear to me that novel Coronavirus - known as COVID-19 continuous to spreads around the country which is dangerous to human life. As of now, a vaccine has not been formulated for Novel Coronavirus. In light of this fact, prevention appears to be the best cure available so far. Moreover, mass gatherings of people at all Social, Cultural, Sports Political, Religious, Academic, Family events and at cinema Halls, Gyms and Night Clubs may also spread person to person transmission of the ibid virus which is dangerous to human being which may leads to serious law and order problem in the district. The Haryana Government has also framed the Haryana Epidemic Disease, COVID-19 Regulations 2020 to avoid the spreading of COVID-19 (Coronavirus).

Whereas, It has been made appear to me that there is a need for restriction on mass gatherings of Twenty or more then Twenty people at public places and Rally, Demostration, all Social, Cultural, Sports, Political, Religious, Academic, Coaching Centres, Religious places and Family events and on operations of Cinema Halls, Gyms and Night Clubs, Hotels/Dhaba's to prevent the person to person transmission of the ibid virus which is dangerous to human life.

Now, therefore, **I, Sujan Singh, I.A.S, District Magistrate Kaithal** in exercise of the powers vested in me by virtue of section 144 of the Code of Criminal Procedure, 1973, do hereby prohibit mass gatherings of Twenty or more then Twenty people at public places and Rally, Demostration, all Social, Cultural, Sports, Political, Religious, Academic, Coaching Centres, Religious places and events to prevent the person to person transmission of the ibid virus. Further, in exercise of the same powers, I also prohibit the operations of all Cinema Halls, Gyms, Night Clubs and Hotels/Dhaba's within district Kaithal.

This order shall not apply to the Police/Military/Para Military Forces and other Public servants on duty.

This Order shall come into force with immediate effect and shall remain in force till 31-03-2020 if not revoked earlier.


Any person contravening this order shall be punishable u/s 188 of Indian Penal Code. Superintendent of Police, Kaithal shall be responsible for implementation of this order.

Superintendent of Police, Kaithal, Sub Divisional Magistrates, Estate Officer, HSVP, Kaithal/Principal of All Govt/Private Colleges in this district, District Education Officer and District Elementary Education Officer, Kaithal shall be responsible for the compliance of the above order.

This order shall be promulgated in area of Kaithal district by beat of drum, by announcement through the publicity van of Public Relation Department and by affixing of the copies of this order on the notice boards of District Courts/ Sub Divisions/Tehsil Courts/Police Stations and through print and electronic media.

In view of requirement of the situation which has become emergent, this order is passed ex-parte and is addressed to the public at large.
