
In this connection, it is intimated that as per the Bio Medical Waste Management Rules, 2016 and amendments thereof the Biomedical Waste generated from the hospital shall be collected and disposed in accordance with the procedure specified, within 48 hours by the Common Bio-Medical Waste Treatment Facilities (CBWTFs). Further Central pollution Control Board also issued specific guidelines to handle the Bio-Medical waste during the treatment of COVID-19 and copy of the same was circulated by Haryana State Pollution Control Board to all the concerned Vide letter No.HSPCB/HQ/SWM/2020/1243-84 dated 23/3/2020.

Haryana State Pollution Control Board has authorised 11 Common Bio-Medical Waste treatment Facilities (CBWTFs) to cater all the hospitals operating in the State of Haryana. They are collecting the waste from the Hospitals in GPS connected Vehicle on daily basis. These dedicated vehicles are marked separately with "Bio-Hazard" and its logo.

Due to the prevailing situation of the lockdown by the Government, the police is not allowing the vehicle of Common Bio-Medical Waste treatment Facilities (CBWTFs) for movement on roads for collection of waste from Hospitals and to reach back to the facility. The details of authorised Common Bio-Medical Waste treatment Facilities (CBWTFs) are enclosed herewith.

In view of above it is requested to kindly instruct the concerned to permit the CBMWTFs vehicles and persons for collection and disposal of biomedical waste from the hospitals to the facilities. Necessary permits/passes may be issued to the vehicles and persons involved in the collection and disposal of Bio-Medical waste.


