

ORDER UNDER SECTION 144 OF CODE OF CRIMINAL PROCEDURE, 1973

Whereas it has been brought to my notice by Superintending Engineer, Bhakra Water Services Circle Kaithal vide letter No. 2907/8-E dated 23-05-2020 that the Sirsa Branch is a main carrier channel of this circle and irrigates the area upto Hisar district. The Supply of Kharif crop will run continuously upto 30-09-2020. Three no incidents was occurred on Sirsa Branch during last year in which four Nos. people drowned in the channel and lost their life. A large number of persons/childrens gather near the canals for taking a bath and Jumped in canals/Water Channels many of them even don't know swimming or are not skilled to with stand the water flow incidents of death by drowning.

Whereas, to take bath/ Jumped in such type of fast flowing water in the Sirsa Branch at Village Kaul, Chandana Head & Bridge RD 150000 & RD 166840 and other canals has the potential of adversely affecting the safety of human being and children in particular.

Whereas, it is essential that bathing/Jumping should prohibited to prevent such injury and danger to human health and safety, the fast water flow in the Sirsa Branch at Village Kaul, Chandana Head & Bridge RD 150000 and RD 166840 & other canals may lead to.

Whereas, I am satisfied that immediate measures are required to be taken for prevention of such danger to human health and safety and for maintenance of law and order.

Now, therefore, **I, Sujan Singh, I.A.S, District Magistrate, Kaithal** by virtue of power conferred upon me under section 144 of code of Criminal Procedure 1973, do hereby prohibit the entry of persons/children into & around the canals bathing/Jumping the area near sirsa branch at Village Kaul, Chandana Head & Bridge RD 150000 and RD 166840 Sirsa Branch upto 01-06-2020 to 30-09-2020 within Jurisdiction in Kaithal District.

Superintending Engineer, Irrigation Kaithal is directed to fix a notice board at every site direction a total prohibition for entry in & around all the canals/water channels and also depute officials for checking and ensure compliance of above orders.

This order shall be promulgated in the district Kaithal by beat of drum, announcement through van of Public Relation Department, by affixing the copy of this order on the notice board of District Courts, Sub Divisional and Tehsil Courts, Municipal Committee Office, Railway Station and other public place as well as in Police Stations.

This order shall not apply on the expert divers of District Administration as well as Police Force or Military Personnel. In view of the requirement of the situation which has become emergent, this order is being passed ex-parte.

For the violation of the aforesaid order, if any person is found guilty, he will be liable for punishment under Section, 188 of the Indian Penal Code.

This order shall take effect immediately and shall remain on 01-06-2020 to 30-09-2020.
