

**OFFICE OF DISTRICT MAGISTRATE, KATHAL**

**ORDER UNDER SECTION 144- OF Criminal Procedure, 1973**

Whereas the MHA Govt. of India, under the directions passed by National Disaster Management Authority under Section 6 (2) (i) of the Disaster Management Act, 2005, the Union Home Secretary being the Chairperson, National Executive Council, in exercise the powers conferred under Section 10(2) (i) of the Disaster Management Act, 2005 has issued order bearing No. 40-3/2020-DM-1(A) dated 29-06-2020 whereby the lockdown in the Containment Zones has been extended upto 31-07-2020 and issued new guidelines as annexed therewith on lockdown measures for strict implementation.

Now, I am satisfied that the directions, in compliance of the aforementioned orders, are necessary for strictly prohibiting the movement of individuals, except for essential activities, between 10:00 PM to 05:00 AM in the interest of maintenance of public health, hygiene and safety in view of COVID-19 pandemic.

Therefore, **I, Sujan Singh, IAS, District Magistrate, Kathal** in exercise the powers vested in me by virtue of Section 144 of the Code of Criminal Procedure, 1973, do hereby strictly prohibit the movement of individuals between 10:00 PM to 05:00 AM, except for essential services, within the district, as well as movement outward the district with immediate effect till 31-07-2020. I also directed that makes mandatory for persons as well as for owner coming from outside/hotspot areas to inform local authority/Police authority in public interest.

The order shall be published for the information of general public and shall be promulgated within the revenue limits of district Kathal through publicity van of Public Relations Department and also by affixing copies of this order as District, Sub Divisional, Tehsil Courts, Police Stations and other public places as well.

The compliance of this order shall be strictly enforced and ensured by all Executive Magistrates/Police Officials on duty and any violation of the same shall be strictly dealt with as per sections of 188, 269 & 270 of the Indian Penal Code.
