ORDER

Sealing down of Containment Zone operations:- As per guidelines of containment zone, the operations will be scaled down if no secondary laboratory confirmed COVID-19 case is reported from the containment and buffer zones for at-least 4 weeks after the last confirmed test has been isolated and all his contacts have been followed up for 28 days.

Accordingly, following which was declared as containment zone vide orders of District Magistrate, Kaithal is eligible for sealing down and hence, **denotified as containment zone** as per the provisions given in containment plan by Ministry of Health & Family welfare Govt. of India. Further, following adjoining area are also **denotified as Buffer Zone**.
