

ORDER UNDER SECTION 144 OF THE CODE OF CRIMINAL PROCEDURE, 1973

Whereas it has been made to appear to me that there is likelihood of causing tension annoyance and disturbance of public peace and tranquility within the limit of Examination centers on account of Secondary/Sr.Secondary (Academic/Open School Full Imp. Partial Imp. Additional/R-appear) & D.EL.ED Examinations to be held on **26.10.2020 to 23.11.2020** in the schools of the district being conducted by the Haryana School Education Board, Bhiwani.

Whereas it has been made to appear to me that the gathering of the five or more person is likely to cause obstruction in the maintenance of peace and tranquility within the area of about 200 meters around the Examinations centers in the District Kaithal (List attached).

Now, therefore, in exercise of powers vested in me by virtue of section 144 of Code of Criminal Procedure, 1973, **I, Sujan Singh, IAS District Magistrate, Kaithal** do hereby prohibit the gathering of the five or more person in the area of 200 meters around the Examination centers in Kaithal District during the period on **26.10.2020 to 23.11.2020** Photo-stat business is banned only during the Examination during 02:00 PM to 05:00 PM.


This order shall not apply to the police and other public servant on duty. In view of the emergent situation of shortage of time, this order is being passed ex-parte and is being addressed to the public in general.

This order shall be promulgated within the limits of Examination centers in Kaithal District by beat of Drum, by announcement through the publicity van of public relation department, by fixing of the copies of this order on notice boards of the Examination centers, sub-divisional and Tehsil Courts and public places as well as the police stations.

In view of the requirement of the situation which has become emergent, the order is passed ex-parte and is addressed to the public generally to maintain peacefully Examination in the Kaithal District.

For the violation of the aforesaid order, if any person found guilty, he will be liable for punishment under section, 188 of the Indian Panel Code.
