**ORDER**

**Sealing down of Containment Zone operations:-** As per guidelines of containment zone, the operations will be scaled down if no secondary laboratory confirmed COVID-19 case is reported from the containment and buffer zones for at-least 2 weeks after the last confirmed test has been isolated and all his contacts have been followed up for 10+07 days.

Accordingly, following which was declared as containment zone vide orders of District Magistrate, Kaithal is eligible for sealing down and hence, **denotified as containment zone** as per the provisions given in containment plan by Ministry of Health & Family welfare Govt. of India. Further, following adjoining area are also **denotified as Buffer Zone.**


