

## OFFICE OF DISTRICT MAGISTRATE KAITHAL


In pursuance of guidelines/order issued by the Haryana State Disaster Management Authority Haryana Chandigarh vide Memo No. DMC-PO-I-2020/4863 dated 23-04-2021, the prevailing COVID-19 pandemic is posing a threat to public health, it is necessary to take steps to prevent its spread in Kaithal District.

In exercise of powers conferred under Disaster Management Act, 2005 by the undersigned in the capacity as Chairperson, District Disaster Management Authority, hereby ordered that closed the shops in such crowded area in District Kaithal after 06:00 P.M. and open of restaurants/eating places only for home delivery with immediate effect.

Any person violating these measures will be preceded as per the provisions of Section 51 to 60 of the Disaster Management Act, 2005, beside legal action under Section 188 of the Indian Penal Code, and other provisions as applicable. Extracts of these penal provisions are at Annexure-I

This order shall come into force with effect from 23-04-2021 and shall remain in force till further orders.

Superintendent of Police Kaithal, SDM's, Incident Commanders, concerned B.D.P.O., District Municipal Commissioner Kaithal, E.O.,M.C., Kaithal and concerned Secretary, Municipal Committee shall strictly enforce the above measures and are also advised to ensure that sufficient numbers of drug / pharmaceutical shops and Grocery stores may be allowed to remain open after 6.00 p.m. in the crowded markets, as is considered necessary and on situation assessment basis, so as to avoid any inconvenience to citizens
