

**ORDER UNDER SECTION 144 OF CODE OF CRIMINAL PROCEDURE, 1973**

Whereas, the COVID-19 has been declared as pandemic by the World Health Organization and National Disaster Management Authority, being satisfied that country is threatened with the COVID-19 pandemic.

Whereas, it is evident that there has been an exponential surge in the Covid cases in the District Kaithal, and necessary measures are to be adopted to contain the spread of the Covid-19 and also to ensure minimum collateral damage to the system.

The Government of Haryana has considered it necessary to take effective measures to prevent and contain the spread of the Covid-19 virus in the state of Haryana including district Kaithal in the interest of maintenance of public health, hygiene and safety.

Now, therefore, in exercise of the powers vested in me by virtue of section 144 of code of Criminal procedure, 1973. **I, Sujan Singh, I.A.S, District Magistrate Kaithal** do hereby prohibit the gathering of more than four people, unless specifically permitted in the jurisdiction of District Kaithal.

This order shall not apply on police force and other public servants of duty, person of medical industries/ institutions, persons working in sector related to essential products/services.

This Order shall come into force with effect from 27-04-2021 to till further order.

Any person contravening this order shall be punishable u/s 188 of Indian Penal Code. Superintendent of Police, Kaithal shall be responsible for implementation of this order.

It shall be published for the information of public in general through the press and publicity Van of Public Relation Department and by affixing of the copies at notice board of all offices of the district administration, Superintendent of police, District Courts/ Sub Divisions/Tehsil Courts/Police Stations and through print and electronic media.

The Superintendent of Police Kaithal, Sub Divisional Magistrate's and concerned Incident Commanders-cum-Tehsildar/Naib-Tehsildar in their respective areas shall be responsible for enforcement of the above prohibitory orders in letter and spirit.
