In pursuance of SOPs/ Guidelines issued by Haryana State Disaster Management Authority, Chandigarh vide memo no. DMC-SPO-2021/2707 dated 26-04-2021, procedure for providing permission to the public for gatherings is mentioned below:-

Applicant may submit the application in the office of concerned Sub Divisional Magistrate in any suitable form i.e. either in Hard copy or through email on official email ID provided by Sub Divisional Magistrate. On the same day of receiving of application, O/o Sub Divisional Magistrate will further sent the soft copy of application through email to the Police Department, Concerned Tehsildar/ Naib Tehsildar, Municipal Corporation/Committee concerned for obtaining a No Objection certificate on the same, If the office concerned doesn't have any objection, then they shall provide their NOC by 11:00 AM of the next day of receipt of application by email. In case any office fails to provide the objection on the application by 11:00 AM, then the application will be deemed to have been cleared and permission shall be issued to the applicant without any delay.

This order shall be promulgated through print & electronic media by District Information & Public Relations officer, Kaithal and by affixing of the copies of this order on the notice boards of the District Courts/ Sub Divisional Tehsil Courts/ Police Station etc.
